Transcribed in 2024 from the original hand-written journal by Nancy Osborn Johnsen, great-great granddaughter of Deborah Fox Standing – who was Clerk of the Bear Creek Monthly Meeting of Women Friends during this period. [Note: Deborah was from England, which guides the spelling of some of the words she used in the earlier years.] See more comments at the end of this transcription.*

1<sup>st</sup> All our meetings for worship and discipline have been attended, generally by most of our members, a few are remiss in that important duty. Unbecoming behavior avoided. The hour of meeting pretty well observed.

2<sup>nd</sup> Most friends appear to maintain love toward each other as becomes our Christian profession. Tale bearing and distraction discouraged and most avoided. No apparent differences among us.

3<sup>rd</sup> Most friends endeavour by example and precept to educate their children and those under their care in plainness of speech, deportment and apparel. They endeavour to guard them against pernicious reading and from corrupt conversation and they are encouraged to read the Holy Scriptures and other religious books.

4<sup>th</sup> There has been no dealing with offenders since last report.

5<sup>th</sup> Friends appear to maintain a faithful testimony against slavery, oaths, military services, clandestine trade, prize goods and lotteries. A few not quite clear of attending on a hireling ministry.

6<sup>th</sup> Friends are careful to live within the bounds of their circumstances and to avoid involving themselves in business beyond their ability to manage or in hazardous or speculative trade. They are just in their dealings and punctual in complying with their contracts and engagements and in paying their debts reasonably.

7<sup>th</sup> Friends of clear of importing, vending, distilling and the unnecessary use of all intoxicating liquors. A few not clear of attending a place of diversion. Moderation and temperance observed.

8<sup>th</sup> No poor amongst us requiring aid.

9<sup>th</sup> No schools amongst us under our control.

10<sup>th</sup> No new meetings settled and none discontinued.

11<sup>th</sup> No Ministers or Elders recorded, and none deceased the past year. One Minister and four Elders within our limits.

12<sup>th</sup> Numbers of families 8, parts of families 8. Every family is furnished with a copy of the Holy Scriptures.

13<sup>th</sup> The Queries addressed to the Quarterly, Monthly and Preparative Meetings are read, and endeavours used to answer them as directed.\

The Treasurer reports the sum of 60 cents as contributed toward the Yearly Meeting's stock which is directed to be forwarded to the Quarterly Meeting.

**10<sup>th</sup>** No new meetings settled; and none discontinued.

**11<sup>th</sup>** Ella Newlin recorded an Elder; none deceased the past year. Five Elders and one Minister.

**12<sup>th</sup>** Ten families; 18 parts of families, every family is furnished with a copy of the Holy Scriptures as far as we know.

13<sup>th</sup> Endeavors have been used to answer the Queries as directed.

***Comments regarding this set of Minutes:***

*These recorded Minutes of the Bear Creek Monthly Meeting of Women Friends (Conservative) span a period of nearly a decade from the beginning of 1889 to the midpoint of 1899. These meetings probably took place in the first-built Conservative Friends Meeting House immediately east of the Bear Creek Cemetery within Section 23 of Union Twp., Dallas County – and across the road from a Friends Meeting House (later, a Church was built) which was occupied by the Progressive branch of Bear Creek Friends. The two groups were organized as a result of a split within the Bear Creek Friends in 1877. The Bear Creek group of Progressive Friends is referred to in these Minutes as “the other Body.”*

*The Men's Monthly Meeting and Women's Monthly Meeting met separately for business discussions but then consolidated any decisions made by either group, and each was presided over by a Clerk and Assistant Clerk. The Monthly Meeting as a whole had a Recorder and an elected group of Overseers, consisting of those designated as Elders and Ministers. Committees were routinely appointed to handle business concerns such as Books & Tracts and Education. One committee was appointed to “provide oversight and care” in the case of funerals and burial. During the entire span of these Minutes, Deborah Standing was re-appointed as Clerk of the Women's Meeting, and Ella Newlin and Mary Mills were most often serving in many roles. According to these minutes the entire membership of these Conservative Friends in the Bear Creek community consisted of only 7 to 12 families during this period of time.*

*The format of the Minutes is fairly formal and quite repetitive; it seems that they followed a consistent “template” from which there was little deviation, and each month two representatives were sent to represent the women at the Quarterly Meeting, which may have been held elsewhere. One issue with which the Monthly Meeting apparently struggled was the “dealing with offenders” – presumably members who were not following all the prescribed “rules” of the Meetings. They made decisions on who would*

*be admitted into membership and those who should be removed, and also approved and presided over at least one wedding within the Meeting – that of Josiah Standing and Frances Nicholson on 3/07/1898.*

*Prior to 1892 Bear Creek Monthly Meeting (Conservative) had had no formal school of its own, so one important business matter was the building of a little school house and the hiring of a series of appropriate Quaker teachers. The building of a school structure took place in the fall of 1892 on land provided by Abner and Ella Newlin, as reported in these Minutes.*
