Newlin, William H. Henry Standing and Milton Miller to the following described premises to David Davis,

Commencing at a point (40) forty rods East of the North West Corner of the North East quarter (4) of Section Nine (9) Township Seventy seven (77) North of Range Twenty eight (28) West 5th P.M. Iowa - thence running South Twenty (20) rods, thence West Forty (40) rods, thence North Ten (10) rods - thence East Sixteen (16) rods thence North Ten (10) rods thence East to the place of beginning.

Containing Four (4) acres more or less. It being evident by the above described deed that the remaining one acre is the graveyard belonging to Bear Creek Quarterly Meeting of Friends, thence described, to wit: Beginning at the North West Corner of the North East Quarter (4) of Section
